Articles Of Incorporation
Of
European - American National Foundation, Inc.

The undergigued, acting as incorporators of a corporation under Chapter 617.

Florida Statutes, Corporations Not For Profit, adopt the following Articles of Incorporation for such corporation:

- 1) The name of the corporation is: European-American National Foundation Inc.
- 2) The purpose of the corporation is to advise, educate, and promote the uncestral heritage and Western Culture of the United States. The federation shall encourage the broadest participation in the civic arises of the compy inciding and promoting the English language and American culture as rooted by our European ancestors, the founding fathers of this great country.

 - 4) The period of the corporation's duration is perpetual.
