We, the undersigned, acting as incorporators of a non-profit corporation under Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I.

NAME: the name of this corporation shall be THE SONS AND DAUGHTERS OF THE SOUTH, INC.

ARTICLE II.

PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS:

ARTICLE III.

PURPOSE: To enlighten the community awareness of and to benefit various needs within the community such as educational needs; food for the needy through food banks, etc.; health and safety needs of the disadvantaged; to provide summer camps and tutoring for the disadvantaged; to assist with needs of senior citizens; all of such services to be funded through community fund raising events and through contributions.

ARTICLE IV.





