The undersigned incorporator hereby forms a not for profit corporation under Chapter 617 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: SOUTH FLORIDA BANDITS BASEBALL ORGANIZATION, INC. The address of the principal office of this corporation shall be: 6506 Las Flores Boulevard, Boca Raton, Florida, and the mailing address shall be the same.

ARTICLE II. NATURE OF BUSINESS

The principal activity and nature of this business is promotion and organization of amateur baseball activities. This not for profit corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.
