The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I -- NAME

The name of the corporation shall be: COMMUNITY ENHANCEMENT ASSOCIATION, INC.

ARTICLE II -- PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be: 20120 S.W. 115 Avenue, Miami, Florida 33189.

ARTICLE III -- PURPOSE(S)

This organization will be operated exclusively for charitable, scientific, literary and/or educational purposes as described in Section 501(c)(3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax law ("Code") including, but not limited to the following particular purposes:

- To receive, by contribution, gift, bequest, devise, or in any other manner, money, assistance, and any other form of real personal, or mixed property, from any person, firm or corporation to be used in the furtherance of the purposes of this organization. This organization may also receive all funds generated by interest on trust accounts;
- The organization may contract and be contracted with, sue and be sued, invest and reinvest the funds of the organization and do all acts and things requisite, necessary, proper, or desirable to carry out and further the purposes for which the organization is formed, authorize capital expenditures, accumulations or reserves as may be necessary to meet the reasonable working needs of the organization, retain professional investment advisory services, and, through

its directors adopt rules of procedure reasonable necessary or helpful in carrying out the purposes and powers of the organization in managing and administering the programs of the organization;

(f) For such other programs for the benefit of the members of the organization and the general public as are specifically approved from time to time.

ARTICLE IV -- MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as specified by the By-Laws.

ARTICLE V -- LIMITATION OF CORPORATE POWERS
