ARTICLES OF INCORPORATION
OF
HOLLYWOOD THREE LAKES CIVIC ASSOCIATION, INC.

The undersigned incorporator, acting as incorporator of a nonprofit corporation pursuant to chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE 1: NAME

The name of the corporation shall be Hollywood Three Lakes Civic Association, Inc.

ARTICLE 2: PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and mailing address of this corporation shall be 1223 Van Buren Street, Hollywood, Florida.

ARTICLE 3: PURPOSE

The purpose of this corporation shall be to promote the general welfare of the neighborhood known as the Hollywood Lakes Section, Hollywood, Florida and that of the entire City of Hollywood, Florida by engaging in civic projects.
