## AMENDED ARTICLES OF INCORPORATION OF

### FAMILY OF GOD BAPTIST CHURCH, INC. A NOT FOR PROFIT FLORIDA CORPORATION

The Amended Articles of Incorporation of the undersigned, all of whom are citizens of the United States and over the age of twenty-one years or more, desiring to replace their previously filed Articles of Incorporation and to maintain their status as a Not for Profit Corporation under the laws of the State of Florida do hereby certify:

#### **FIRST**

The name of the Corporation shall be Family of God Baptist Church, Inc.

#### SECOND

The place in this state where the principal office of the Corporation is to be located is 901 East Business Highway 98, Panama City, Florida 32401.

#### **THIRD**

Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes within the meaning of 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. More specifically the primary purpose for which this Corporation is organized is:

- a) To incorporate that certain church organization known as the Family of God Baptist Church, Inc.;
- b) To provide members of the Family of God Baptist Church, Inc. and the general public a place for worship, fellowship, Christian education, evangelism and missionary endeavors;
- c) To purchase, lease or otherwise hold ownership of real and or personal property to further the purpose set for in paragraph a).

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by a Corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


