ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be:

Principal place of business and mailing address

ARTICLE III

Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

To educate and inform the general public about the social, legal and health effects of tobacco use; To create stress reduction support groups for smokers; To attempt to intervene and mediate in situations where an anti-smoking social climate has caused unfair rules and discriminatory practices to be directed at smokers; ... (See added page: Article III Purpose)

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

The three original founders will serve as directors and remain in office for an initial minimum term of ten (10) years, after which time directors will be elected to the board by a majority vote of the remaining board to terms of five (5) years. Directors who resign, die while in office, or are removed for malfeasance will, after due consideration, examination and review of qualified candidates, be replaced by joint agreement of remaining board.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows: Members are non-voting members in all matters regarding the corporation, but may vote in matters affecting local support groups, provided such decisions do not run contrary to official corporate policy. Membership may be asked to sign petitions and to vote in opinion polls.






