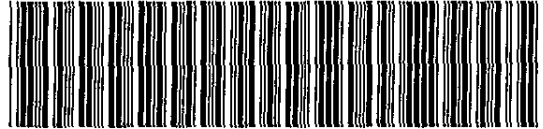



ARTICLES OF AMENDMENT  
OF  
**SAINTS EQUIPPED TO EVANGELIZE, INC.**  
a Florida Not For Profit Corporation

Pursuant to Florida Statutes §617.1006, this Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation:

1. That the articles of incorporation of **SAINTS EQUIPPED TO EVANGELIZE, INC.**, are hereby amended by striking Article IV in its entirety and substituting the following:

“ARTICLE IV.  
PURPOSES AND POWERS

S.E.E. is committed to apostolic church planting, and is aiding in this effort through short term evangelistic teams, which go into the field and minister alongside career missionaries and local church workers.

Additionally, S.E.E. offers, through a Bible Institute, in cooperation with appropriate stateside educational institutions, the opportunity for college students to participate in formal education in Italy, in the hope that the eyes and hearts of those students will be opened to the need of others, outside the United States, to hear the gospel message.

Through these means, short termers and college students are gaining experience and training on the mission field, while being used to fulfill the Great Commission.”

2. That the articles of incorporation of **SAINTS EQUIPPED TO EVANGELIZE INC.**, are hereby amended by adding the following paragraph to Article V. as follows:

“(4) Acting in accord with the religious, educational, and charitable purposes for which the Corporation exists, it may be the case that, from time to time, students participating in the Corporation’s Bible Institute may be the recipient of financial aid granted by the Corporation’s Board of Directors or its designee. This financial aid will be granted upon the sole determination of the Board or its designee upon evaluation of the applicant and his or her need. The mechanics of such evaluation may change from time to time, but the intent of the evaluation will be to give such assistance, based upon available funds, coupled with the needs and merit of the applicant, as is deemed appropriate.”

The aforesaid amendment was unanimously adopted by all of the directors on the

13<sup>th</sup> day of MAY, 2005.
