THE UNDERSIGNED subscribers of these Article of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation not for profit under the laws of the State of Florida.

ARTICLE I. NAME: The name of this corporation shall be FRIENDS OF THE WILDWOOD LIBRARY, INC. 702 Webster Street Wildwood, FL 34785

ARTICLE II. NATURE OF BUSINESS: The general Nature of the business to be transacted by this corporation is:

To promote public use of the Wildwood Public Library and appreciation of its value as a cultural and educational asset to the community and to encourage the extension and improvement of its services.

ARTICLE III. QUALIFICATIONS AND MANNER OF ADMISSION OF MEMBERS: Any person, family, firm, or corporation interested in the purpose of this corporation may become a member upon payment of dues as provided in the by-laws.
