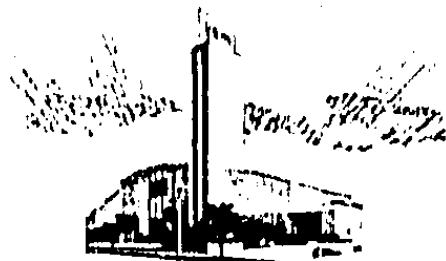




**Certificate of Designation**
