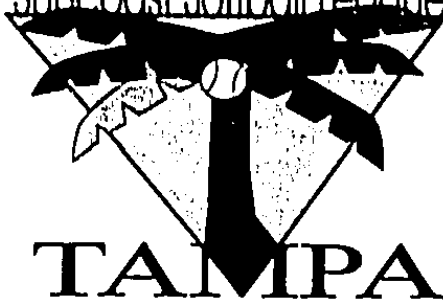

The undersigned hereby executes and acknowledges these Articles of Incorporation for the purposes of forming a Not for Profit corporation in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of the corporation shall be The SUNCOAST SISTERS SOFTBALL LEAGUE, INC.

ARTICLE II

Principal Place of Business and Mailing Address

Purpose

The general purpose of this corporation shall be a softball league. This corporation is authorized to transact any and all lawful business under the Florida Not For Profit Corporation Act.
