ARTICLE OF INCORPORATION
OF
SWORD OF THE LORD MINISTRIES INC.

WE, the undersigned, as subscribers to these ARTICLES OF INCORPORATION being persons to competent to contract, hereby associate ourselves for the purpose of building churches and constituting an evangelistic association to operate in accordance with the laws of God and as a non-profit corporation pursuant to the applicable provisions of the statutes of the State of Florida relative to corporations not for profit. To this end and purpose, we hereby covenant and agree as follows:

ARTICLE I: NAME

The name of the corporation is:
SWORD OF THE LORD MINISTRIES INC.

ARTICLE II: DURATION

The corporation shall have perpetual existence.

ARTICLE III: PURPOSE

The objectives and purposes for which this non-profit corporation is constituted, and this corporation organized, are as follows:

(a) to disseminate the gospel of Jesus Christ and the word of God, to the end that the people of God may be conformed to the image of Jesus Christ;

(b) to act with charitable concern for and to help the poor, widowed, orphaned, afflicted, imprisoned, under-privileged or aged persons, both domestically and in foreign lands; and to develop and carry out programs of social action for this end;

(c) to pray for the needs of all men and for local and national leaders in Government;

(d) to support and encourage communications and extension of the Christian life and witness by sound and comprehensive preaching and teaching of the Holy Bible and of the gospel of the Lord Jesus Christ by the Holy Ghost to all men, not only by conventional modes, but by all means which will accomplish such communication, extension, teaching and preaching, including by not limited to media of communication developed by modern technology; and in aid of such communication, extension, teaching and preaching, by not for private profit, to sponsor, participate in, conduct or engage in all broad-casting, television, radio, advertising, the printing, or reproduction, or publication of books, pamphlets, or other materials, for establishment and operation of a school, or other institution, or other kind of organization, or other activity, or other project, or other activity, by resident or traveling evangelists, laymen, or other leaders; and to receive, administer, for such purposes, as of land, and to pay, or contribute, or expend, or otherwise lawfully contribute

and to recognize, support and cooperate with various
ministries established by God to equip believers to fulfill
their respective functions as members of the body of Christ
and to bring the whole body of Christ to maturity and
completion.

Directors of the Corporation. They will be elected
