ARTICLES OF INCORPORATION

OF

PAUL DANIELS MINISTRIES, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporations not for profit, under Chapter 617 of the Florida Statutes, and respectfully petition the Secretary of State for approval of such incorporation under the following proposed Articles of Incorporation:

ARTICLE I

Name and Address

The name of this corporation shall be PAUL DANIELS MINISTRIES, INC., its principal place of business is 1844 Tristram, Lakeland, Florida 33813, and its initial registered agent at such address is Paul Daniels.

ARTICLE II

Purpose

The general purposes and objects of this corporation shall be to conduct for religious worship and instruction, churches, music ministries, teaching and witnessing in nursing homes and to the handicapped, schools, parsonages, and other institutions connected therewith of a religious, educational, charitable and benevolent character, and to advance spiritual growth, and enlightenment, moral and personal purity among its own membership and the people of the community in which it is located; to disciple its membership, to promote home and foreign missions; to assist spiritually, physically, and financially; and, to aid in the spread of the Gospel of Jesus Christ to the ends of the earth; also, to educate, disciple, prepare and ordain Christians for the ministry of the Gospel of Jesus Christ; and for the purpose of promoting the foregoing objects, this corporation shall have the right to acquire, either by gift or purchase, and to hold, own, sell, mortgage or encumber in any manner, lease and improve real estate and personal property for itself and others, either as Trustee or otherwise.

ARTICLE III

Use of Income

All revenue, profit, income and money received from the conduct of such business or enterprise is to be used and employed in religious, educational, charitable, benevolent and missionary work and not for the benefit of the members of said corporation, either individually or collectively.

ARTICLE IV

Powers

This corporation is to have the power to do any and all things necessary or expedient for carrying out the said objects and purposes of the corporation, and in general to possess all rights, privileges and immunities, and enjoy all the benefits granted to corporations of similar character under the laws of the State of Florida; provided, however, that this corporation shall have no power to mortgage, sell or otherwise dispose of any property without the consent of the membership of this corporation, evidenced by a resolution duly passed in accordance with the By-Laws of the corporation.

ARTICLE V

Qualifications for Membership and Manner of Admission

Every person who believes in repentance toward God, and faith in Jesus Christ, as Savior and Lord, and who is willing to confess to Him publicly as Lord and King and follow Him in baptism, and to observe the ordinances of Christ and to be governed by His laws, is qualified and eligible for membership in this corporation.

The membership of this corporation shall consist of such persons as from time to time may become members in the manner provided in the By-Laws.

ARTICLE VI

Term of Existence

This corporation shall have perpetual existence.

ARTICLE VII

Subscribers

ARTICLE VIII

Board of Trustees

Section 1. The business affairs of this corporation shall be managed by the Board of Trustees. This corporation shall have two Trustees initially. The number of trustees may be increased from time to time, by the By-Laws, but shall never be less than two.

Section 2. The members of the Board of Trustees shall be members of the corporation.

Section 3. Members of the Board of Trustees shall be elected and hold office in accordance with the By-Laws.

Section 4. The names and address of the persons who are to serve as members of the Board of Trustees for terms not longer than five (5) years, or until the first annual meeting of the corporation are:

ARTICLE IX

Officers

Section 1. The officers of the corporation shall be a President, Vice President, Secretary, Treasurer, and such other officers as may be provided in the By-Laws.

Section 2. The names of the persons who are to serve as officers of the corporation until the first meeting of the Board of Trustees are:

Section 3.

The officers shall be elected at the annual meeting of the Board of trustees or as provided in the By-Laws.

ARTICLE X

By-Laws

The members of the Church shall have the right to make and adopt such By-Laws as the shall deem proper and advisable and such By-Laws shall be made, altered or rescinded upon a majority of the members present and voting, at any regular or special business meeting of the corporation called for that purpose, by a two-thirds vote of those present.

ARTICLE XI

Amendments

Section 1. These Articles of Incorporation may be amended at a special meeting of the membership called for that purpose, by a two-thirds vote of those present.

Section 2. Amendments may also be made at a regular meeting of the membership upon notice given, as provided by the By-Laws.

ARTICLE XII

Dissolution

Upon dissolution of this corporation, all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501(c)(3) of the Internal Revenue Code, or to the Federal Government, or to a state or local government for a public purpose, and none of the assets will be distributed to any member, officer, or trustee of this corporation.


