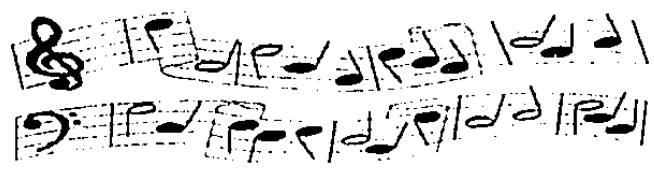

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby associates himself to form a non profit corporation under the laws of the State of Florida.

ARTICLE I

NAME: The name of this corporation is RESURRECTION BRASS MINISTRIES, INC.

ARTICLE II

PURPOSES AND POWERS: The corporation may engage in any activity of business which is permitted under the laws of the State of Florida.

ARTICLE III

CAPITALIZATION: The maximum number of shares of stock this corporation is authorized to have outstanding at any time is FIVE HUNDRED (500) shares of common stock, having par value of ONE DOLLAR (\$1.00) per share.

ARTICLE IV

INITIAL CAPITAL: The amount of capital with which this corporation will begin business is FIVE HUNDRED AND NO/100 (\$500.00) DOLLARS.

ARTICLE V

PRINCIPAL PLACE OF BUSINESS: The name of this non profit corporation shall be RESURRECTION BRASS MINISTRIES, INC. having its principal place of business at 26021 Sandhill Boulevard, E-1, Port Charlotte, Florida 33983 and it's mailing address shall be Post Office Box 1296, Murdock, Florida 33938-1296.

The Board of Directors may, from time to time, move the principal office to any other office within the State of Florida, as the said corporation may desire.

ARTICLE VI

DIRECTORS: This corporation shall have one (1) director initially; the number of Directors may be increased from time to time by the laws adopted by the stockholders, but shall never be less than one (1).





Pursuant to the provision of Chapter 617, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

FIRST, the name of this corporation is RESURRECTION BRASS MINISTRIES, INC.

SECOND, the following amendments to the articles of incorporation were adopted by the corporation:

ARTICLE II

Article II was amended to read:

PURPOSES AND POWERS: The corporation may engage in any activity of business which is permitted under the laws of the State of Florida. The purpose for which the corporation is organized shall be to bind together all followers of Jesus Christ for the purpose of sharing in the worship of God, in the study of Holy Scripture and its meaning, and in making God's will dominant in the lives of men, individually and collectively, especially as that will is revealed to us in the birth, life, teachings, death and resurrection of Jesus Christ.

This corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE III

Article III was replaced with the following language:

LIMITATION OF ACTIVITIES: Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV

Article IV was replaced with the following language:

DISSOLUTION: Upon dissolution of RESURRECTION BRASS MINISTRIES, INC., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future tax Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the county in which the principal office of the organization is then located, exclusively for such purpose.

Article XI was added as follows:

ARTICLE XI

LIMITATIONS: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth elsewhere herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

THIRD: There are no members entitled to vote on these Amendments. The amendments were adopted by the Board of the corporation on this 15th day of June, 1995.

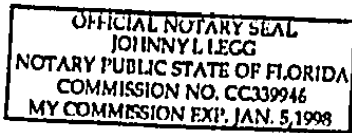
