ARTICLE OF INCORPORATION
OF
FLORIDA NONPROFIT CORPORATION
UNION SOLAR DE UNCION, ANGELICA CORPORATION

The undersigned, for the purpose of forming a nonprofit corporation under Florida Statutes Chapter 617, do hereby make and adopt the following Article of Incorporation.

ARTICLE I
NAME

The name of the Corporation is:

UNION SOLAR DE UNCION, ANGELICA CORPORATION

ARTICLE II
NATURE

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Directors or Officers, except to the extent permissible under the law.

ARTICLE III
DURATION

The term of existence of the Corporation is perpetual.

ARTICLE IV
GENERAL AND SPECIFIC PURPOSES

The specific and primary purpose for which the Corporation is formed are to obtain the goals, principle and ideals described in the following fields:

To research, promote, divulge, study and enhance all aspects of the mysticism.

1. Said aspects shall include but not limited to promoting all available facts to the community at large in order to promote understanding regarding spiritual awareness.

2. To promote information regarding the relationship between man and the unseen world of the spirits.

3. To target certain community groups regarding adequate information in connection with all topics regarding paranormal activity.

4. To help foster, encourage and promote spiritualism related education.

5. To disseminate information and studies regarding all aspects of paranormal activity.

6. To fully utilize all types of news media in order to promote spiritual and awareness. Besides new media other information channels will be used such as booklets, pamphlets, brochures, posters, personal letters, cassettes, videos, lecture services, etc.

7. To form study groups to explore all aspects of paranormal activity.

8. To study methods which will allow communication with the spirit world.

ARTICLE V OFFICERS AND DIRECTORS

The Officers of the Corporation shall consist of a President, Secretary, Treasurer and such other Officers and Assistant Officers as may be provided in the Bylaws. Each officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws. A) The revenue of this organization shall be derived from memberships or initiation fees, from annual membership dues, donations and from such other sources as may be approved by the Board of Directors.

B) Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future Internal Revenue Law) of (b) by a corporation, contribution to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE VI AMENDMENTS

This Corporation may be amended at any regular organizational meeting by vote of Seventy five percent (75%) of the members of said organization attending such regular meeting, provided that the proposed amendment shall have been submitted in writing and read at the next proceeding meeting of said organization, and providing further, that writing notice shall have been given to all members of at least ten days in advance of the day when such amendment is to be voted upon notifying said members that at such meeting a proposal to amend the Corporation is to be voted upon.

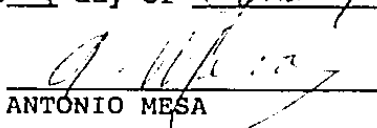

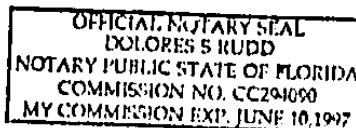
