**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as Incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

**ARTICLE I**

The name of the corporation shall be FERGUSON MINISTRIES, INC.

**ARTICLE II**

This is a not for profit corporation.

**ARTICLE III**

The period of the duration of this corporation is perpetual unless dissolved according to law.

**ARTICLE IV**

The purpose for which the corporation is organized is religious and charitable. To these ends, the corporation is further empowered to transact any and all lawful business permitted under the laws of the United States of America, the State of Florida and any foreign nation or nations as they may apply.

**ARTICLE V**

The corporation is organized on a nonstock basis. Membership in the corporation shall be evidenced by certificates of membership. The corporation may provide for various classes of membership. The enumeration of same, the respective rights and privileges thereof, and method of obtaining membership will be as further set forth in the By-Laws of the corporation.

**ARTICLE VI**

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954, as amended, or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose.

Notwithstanding any other provisions of these articles, this corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law or (b) a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue Law.

#### ARTICLE IX

The corporation's right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation will be provided for in the By-Laws of the Corporation.

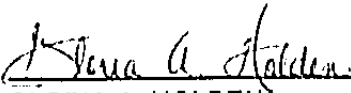

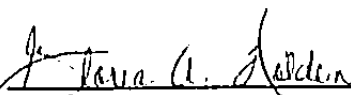
