Articles of Incorporation
of

POLK COUNTY SAVE OUR CHILDREN, INC.
A Corporation For Non-Profit

Pursuant to the Authority and direction of The Board
Members of the ^{/Corporation} by action taken on the 29 day of
September 1994, we the undersigned Board Members associate
ourselves together for the purpose of becoming incorporated
under the laws of the State of Florida, applicable to
corporations not for profit, under the proposed Articles of
Incorporation as follows:

Article I

The name of this corporation shall be POLK COUNTY SAVE OUR
CHILDREN, INC. and is to be located in Bartow, Polk County,
Florida.

Article II

The general purpose of this corporation is to prevent
Juvenile Crime in the Minority Community of Bartow, Fl. and
to help improve citizenship through special Educational and
Cultural Programs.

Article III Membership

Membership shall be comprised of those of African, or African-American descent, and shall include those who desire and have the ability to mentor disadvantaged youth.

Article IV Term

This corporation shall have perpetual existence. If, for any reason, the corporation shall cease to exist as a legal entity, and its charter shall expire or be terminated, the title to all property, both real and personal, shall be vested to the last board chairman, or the next highest officer to be held in trust for the local community.

Article V Board of Directors

Section 1. The affairs of the Corporation shall be governed by a Board of Directors.

Section 2. The number of persons constituting the first Board of Directors shall not be less than three (3) nor more than twelve (12) and the names and addresses of such persons who are to serve as Director until the first election on *January by the board members.*

Article VI By Laws of the Corporation

- Section 1. The By Laws of the Corporation may be amended by a majority vote.
- Section 2. Special meetings of the members for any purpose(s) may, unless otherwise provided by law, be called at any time by the President, or by at least half (1/2) of the Board of Directors, or by half (1/2) of the membership. The purpose of the meeting must be clearly communicated.
- Section 3. The majority of members voting in a meeting shall constitute a quorum, which shall not be less than seven(7) members.
- Section 4. Meetings will be tentatively scheduled on the second and fourth Tuesdays of each month.

Section 5. Authorization for executing documents and distributing funds shall be the responsibility of the Board Chairman, Secretary and Treasurer. However, only two (2) signatures shall be required at any one time.

Article VII

The location and principal office of this Corporation shall be 1985 Laurel Street, Bartow, Florida 33830, or at such other location determined by the Board of Directors.

The initial registered agents is Willie Arthur Bush located at the above address.

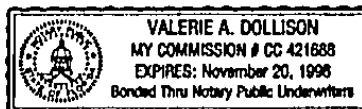
