ARTICLES OF INCORPORATION  
OF  
UNIFICATION OUTREACH MINISTRIES INTERNATIONAL INC.

I and or we, the undersigned incorporators, for the purpose of forming a corporation under the provisions of chapter 617, Florida Statutes, adopt(s) the following Articles of such corporation.

ARTICLES I: The name of this corporation is Unification Outreach Ministries International Inc. 1873 Tigerwood Court. Orlando, Florida 32818.

ARTICLES II: The duration of the corporation shall be perpetual. Unless dissolved according to law.

ARTICLES III: The purpose for which the corporation is organized shall be the transaction of any or all lawful activity for which non-profit corporation may be organized under the Florida General Corporations Act.

Purpose for Teenage Runaway Counseling/Housing Center:  
To provide counseling for teenagers and parents on how to cope with peer pressure, drugs, alcohol abuse, child abuse, and pre-marital sex. To help teenagers better understand their parents point of view.  
To help parents understand teenagers point of view, Through providing spiritual counseling  
To provide housing for teenagers who can no longer live at home for reason that are stated above. To help teenager that have quit school to obtain a high school diploma/G.E.D., and provide the information and assistance to

receive training in a vocational school or college.

Purpose for housing of the Homeless: To provide shelter for people who have lost there job, home, apartment, all income, from previous sources.

to help reestablish and individual or family back into the community. Through spiritual counseling, budgeting, and goal setting.

Purpose for housing for the A.I.D.S/H.I.V. positive Victims: To provide spiritual enrichment through counseling and help individual and family member adjust to the new found knowledge. to provide shelter for victims who no longer have a place to stay because of the disease. Along with transportation to and from the doctor.

Purpose for housing for Spouse Abuse Victims: To provide counseling and housing to spouses and family members who have been abuse by martial partner.

Purpose for Day Care Facilities: To provide day care for children whose parent cannot afford the normal cost of day care due to job pay or financial hardship. To enrich the lives of these children by providing them with cultral enriching activities such as music, art, ballet etc.

Purpose for the Unification Crusades: The purpose of the Unification Crusades are to bring unity to the body of Christ, community, families, youth, young adults, teenages, single parents, senior citizens, and businesses. The Crusades will bring together all races, creed, color and denominational affiliation. The Unification Crusade has four main goals the first goal is to unify the churches and declare war on the devil; secondly to deal with issues that concern our communities youth and what impact the church may have in making a difference in the direction some of them are heading; thirdly our aim is to restore husbands and wives, mothers and daughters, fathers and sons we want to strengthen the family structure again; fourthly we will deal with the churches responsibilities to the homeless, drug addicts, prostitute, homosexuals, lesbian, those who have been molested and incest or abused by another human being. Crusade will provide seminars on these varies subject but will not be limited to these issues only.

Purpose for the need fund will be to establish and account that will be sole for the purpose of helping churches and Individuals in the community who cannot pay there rent or mortgage for a short period of time. these accounts will be set up separately so that they can be monitor on regular basis, this also will apply to utilities bill.

Purpose for the radio/T.V. ministry will be to talk about problem area among our teens and spiritual enrichment, and the need for community involvement.

Purpose for building houses is to provide away for Low-moderate income families to obtain a home that would not be able to under normal circumstances. This will also include housing counseling and budgeting.

Purpose for establishing Unification Outreach Chapters is to bring together a group of people to deal with issue that effect the community and nation as a whole.

The foregoing purpose and activities will be interpreted as examples only and not as limitations, and nothing there in shall be deemed as prohibiting the non-profit corporation from extending its activities to any related or otherwise permissible lawful non-profit business purposes which may become necessary, or desirable for the furtherance of the non-profit corporate objectives expressed above.

ARTICLES IV: Qualification of members and the manner of their admission will be provided for in the bylaws.

ARTICLES V: The initial board of directors are as follows

Sonya Bailey 750 south Orange Blossom Trail Orlando Florida 32805. This board shall serve until the first annual meeting or until their successors are elected and qualified.

ARTICLES VI: This corporation is organized under a non-stock basis.

ARTICLES VII: In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose.

ARTICLES VIII: The name of the initial registered agent of the non-profit corporation is Patreza D. Newton; and the address of the initial registered office of the non-profit corporation, at which the initial registered agent is located is 1873 Tigerwood Court, Orlando, Orange County, Florida, 32818.
