The undersigned, acting as incorporators of a not-for-profit corporation, pursuant to Chapter 617, Florida Statutes, acknowledge the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is **NEW MOUNT MORIAH MISSIONARY BAPTIST CHURCH, INC.**

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of creating and managing the New Mount Moriah Missionary Baptist Church and transacting any or all legal business for which corporations may be organized under Chapter 617, Florida Statutes.

ARTICLE IV - CAPITAL STOCK

This corporation is organized under a non-stock basis.

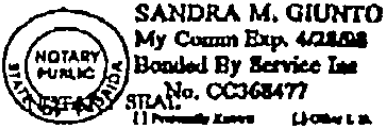
