ARTICLES OF AMENDMENT

95 OCT -5 PH 4: 27

HISPANOAMERICANAS, INC.

Pursuant to Florida Statutes Section 617.1001, the Articles of Incorporation of the above-named Corporation are hereby amended as follows:

- 1. Article III is hereby amended to read as follows:
 - The purposes for which the Centro Para El Desarrollo De Las Artes Hispanoamericanas, Inc. is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
 - Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by any organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
 - Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government. or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located. exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
 - 2. The foregoing amendment was adopted on August 1, 1995.
- 3. There being no members entitled to vote, the amendment was adopted at a meeting of the board of directors by a majority vote of the directors then in office.


