We, the undersigned, with other persons being residents of the State of Florida, do hereby agree to form a corporation not for profit, for educational, charitable and philanthropic purposes, under the provisions of the Florida Statutes, do agree to the following:

ARTICLE I NAME

The name of the corporation is WOODSTOCK PARK BAPTIST CHURCH, INC.

ARTICLE II ADDRESS

The address of the corporation is 924 St. Clair Street, Jacksonville, Florida 32254.

ARTICLE III PURPOSES

The general nature of the objects and purposes of this corporation is to buy, purchase, own, acquire, by gift, devise, purchase or otherwise, real and personal property, and to build, erect, construct, acquire, provide for, maintain and equip suitable buildings, churches, and houses for the benefit, use and occupation of said Church, its members and congregation, in maintaining and fostering public worship and the preaching and teaching of the Word of God and the Gospel of Jesus Christ, and for all other meetings and purposes of the said Church, its members and congregation, to build, construct, erect, maintain and equip schools, mission stations and mission churches, pastor's homes and such other houses or equipment as the Church may desire for carrying on its work.

ARTICLE IV DIRECTORS

The Directors of the corporation shall be elected by the membership of the Church and shall hold office in accordance with the by-laws.

ARTICLE V BY-LAWS

The members of this corporation shall adopt by-laws for the conduct of its business and the carrying out of its purposes as they may deem necessary from time to time. These by-laws must be approved by the Woodstock Park Baptist Church body at a scheduled or called Church business meeting.

ARTICLE VI REGISTERED OFFICE AND AGENT

The initial registered office of this corporation is 924 St. Clair Street, Jacksonville, Florida 32254, and Martha S. Caldwell is the initial registered agent at that address.

become members, by a majority vote of the church members as provided in the by-laws.

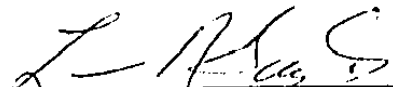
ARTICLE IX AMENDMENTS

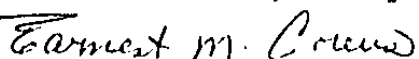
These Articles of Incorporation may be amended at any regular or special meeting of the members called for that purpose, in accordance with the by-laws.

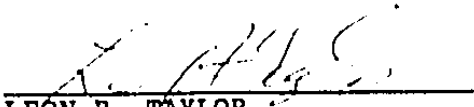
