

The undersigned, acting as incorporators of a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is NAPLES COMMUNITY ICE SKATING FOUNDATION, INC., and the address of the principal office is 1724A Bald Eagle Drive, Naples, Florida 33942.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida for a Not For Profit corporation. The purpose of the corporation includes, but is not limited to, providing ice skating facilities, soccer facilities and other recreational activities for the children and the community of Collier County.
