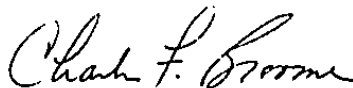

**ARTICLES OF INCORPORATION  
OF**

**CHRISTIAN CONCEPTS, INC., a Non-Profit Corporation**

\*\*\*\*\*

To further common purposes, the undersigned persons agree to organize under these Articles of Incorporation.

**ARTICLE I**

**NAME**

The name of this corporation shall be CHRISTIAN CONCEPTS, INC., a Non-Profit Corporation.

**ARTICLE II**

**ENABLING LAW**

This corporation is organized pursuant to the Corporations Not For Profit Law of the State of Florida, set forth in Part One of Chapter 617 of the Florida Statutes.

**ARTICLE III**

**PURPOSES**

This corporation is organized as a church and shall be operated exclusively for charitable and education purposes by teaching, publishing, proclaiming, making known, preaching, education, distributing, disseminating and declaring by oral, written, or other means the Christian Gospel, the study of the Sacred Scriptures (Bible), and the worship of the Lord Jesus Christ.

This corporation is organized and operated exclusively for non-profit purposes, and no part of any net earnings shall inure to the benefit of any member, director, or officer.

This corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida, provided, however, that this corporation is not empowered to engage in any activity that in itself is not in furtherance of its purposes.

#### ARTICLE IV

##### TERM

This corporation shall have a perpetual existence.

#### ARTICLE V

##### MEMBERSHIP

The membership of the corporation shall consist of all natural persons elected to membership in such manner as the By-Laws may provide. Membership in this corporation shall not be transferable.

#### ARTICLE VI

##### MANAGEMENT OF CORPORATE AFFAIRS

(a) BOARD OF DIRECTORS. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of not less than three Directors. The number of Directors and election of Directors herein provided for may be changed by a By-Law duly adopted by the members entitled to vote. Directors shall be elected or appointed in the manner and for the terms provided in the By-Laws.

#### ARTICLE IX

##### BY-LAWS

#### ARTICLE XI

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for religious purposes and which has established its tax exempt status under Section 501(c)(3) of the

Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

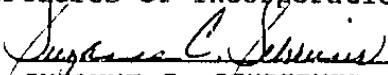

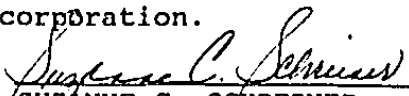
