ARTICLES OF INCORPORATION
OF
HOMELESS RELIEF, INC.

The undersigned acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I
NAME

The name of the corporation is: HOMELESS RELIEF, INC.

ARTICLE II
PRINCIPAL PLACE OF BUSINESS & MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

4 Barbara Court
Ormond Beach, Florida 32174

ARTICLE III
PURPOSES

The specific purposes for which the corporation is organized are:
Said corporation is organized exclusively for charitable purposes in providing shelter, food, clothes and medical care to the poor, indigent, homeless and those individuals left homeless due to natural catastrophies and events, and other acts which the result of which is the same.

Said corporation shall be also empowered to carry out these purposes by making distributions to organizations under section 501(c)(3) of the Internal Revenue code, or the corresponding section of any future federal tax code.

ARTICLE IV
MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is set forth in the bylaws of the corporation.

ARTICLE V
LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless as follows:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VI
DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


