ARTICLES OF INCORPORATION

OF

We, the undersigned, do submit these Articles for the purpose of becoming a corporation not for profit under the laws of the State of Florida, by and under the provisions of Florida Statutes §617 providing for the formation, liabilities, rights and privileges and immunities of corporations not for profit.

ARTICLE I

The name of the Corporation shall be NWSA INSTRUMENTAL PARENTS' ASSOCIATION, INC. Its business shall be carried out at 401 N.E. 2nd Avenue, Attn.: Mr. Roby George, Miami, FL 33132-2204.

ARTICLE II

The general nature of the business to be transacted by the Corporation is as follows:

To provide support and assistance to the students and faculty of the NEW WORLD SCHOOL OF THE ARTS, DIVISION OF INSTRUMENTAL MUSIC.

The Directors shall be elected or appointed as set forth in ... By-Laws of the Corporation.

ARTICLE VI

Mombership in the Corporation is open to any parent of any student who attends the NEW WORLD SCHOOL OF THE ARTS, DIVISION OF INSTRUMENTAL MUSIC. Payment of a nominal fee not to exceed \$10.00 is requested but not required.

Membership may be terminated by any member upon notice to that effect. Membership is non-transferrable.

ARTICLE VII

Upon the dissolution or liquidation of the Corporation, the assets of the Corporation will be turned over the to NEW WORLD SCHOOL OF THE ARTS, with instructions that the funds are to be utilized exclusively for the DIVISION OF INSTRUMENTAL MUSIC.

ARTICLE VIII

The Corporation shall have the power to do all things legally permissible pursuant to Florida Statutes, Chapter 617.

ARTICLE IX

No Officer or Director shall be compensated for services provided but shall be entitled to reimbursement for any expenses advanced.

ARTICLE X

The Corporation shall exist for the maximum amount of time permitted under Florida Law.

ARTICLE XI

To the extent permitted by law, the Corporation shall indemnify and hold harmless each person serving as a Director or Officer of the Corporation, and each person who serves at the request of the Corporation, from and against any and all claims and liabilities to which such person shall become subject by reason of his being Director or Officer of the Corporation, or by reason of any action alleged to have been taken or omitted by him as a Director or Officer. The Corporation shall reimburse each person for all costs, legal and other expenses reasonably incurred by him/her in connection with any claim of liability as to which it shall be adjudged that such Officer or Director is liable to the extent permitted by law.

The rights accruing to any person under the foregoing provisions shall not exclude any other right to which he may be lawfully entitled, nor shall anything therein contained restrict

the right of the Corporation to indemnify for reimburse such person in any proper case even though not specifically provided for herein.

ARTICLE XII

The provisions of this Charter, and each and every article and Section hereof, and the By-Laws of this Corporation shall be considered a part of every contract and transaction to which this Corporation shall be a party. Every person, association and/or corporation dealing with this Corporation is hereby charged with notice and knowledge of this Corporation.
