*THE PASTOR SHALL APPOINT DEACONS, THE NUMBER OF DEACONS APPOINTED SHALL ALL AND BE BE AN ODD NUMBER (ic:one, three, five, etc) AND THE TOTAL NUMBER SHALL BE DETERMINED BY THE NEEDS OF THE INDIVIDUAL CHURCH.

*THE CHURCH SHALL ELECT FROM THREE TO SEVEN TRUSTEES, A TREASURER, CLERK AT THE LAST QUARTERLY MEETING EACH YEAR. IN CASE OF DEATH, RESIGNATION OR REMOVAL OF EITHER OF THE SAID OFFICERS, AN ELECTION SHALL BE HELD AT THE NEXT REGULAR MEETING FOLLOWING THAT AT WHICH SUCH VACANCY SHALL HAVE BEEN ANNOUNCED.

ARTICLES OF INCORPORATION (Attachment #1)

ARTICLE III Purpose(s)

SECTION 1: The general purposes of this corporation shall be to organize into a non-profit association for the purpose of engaging in religious activities.

Specifically, the purposes of the Corporation are:

- E. To carry on the business (not for profit) of christian drama and theatrical acting.
- F. To organize and establish yeath groups for cultural enrichment, and to enhance their moral values in christian growth.
- G. To reachthe disadvantaged, and the less fortunate, with the gospel, by feeding the hungry, sheltering the homeless, visiting thejail and prison and ministering in the street.

SECTION 2: To do any and all other things that are legal, under the laws of the State of Florida, or such other place or places, where it is qualified to operate.
