The undersigned, acting as Incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be:

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

They must be people of a born-again experience and living the life according to the Biblical principles. They must profess their faith in Christ Jesus. ELECTION: (Article VII; Section 2-3 / General Rules)

- THE PASTOR SHALL APPOINT DEACONS, THE NUMBER OF DEACONS APPOINTED SHALL ALWAYS BE AN ODD NUMBER (ie: one, three, five, etc) AND THE TOTAL NUMBER SHALL BE DETERMINED BY THE NEEDS OF THE INDIVIDUAL CHURCH.
- THE CHURCH SHALL ELECT FROM THREE TO SEVEN TRUSTEES, A TREASURER, CLERK AT THE LAST QUARTERLY MEETING EACH YEAR. IN CASE OF DEATH, RESIGNATION OR REMOVAL OF EITHER OF THE SAID OFFICERS, AN ELECTION SHALL BE HELD AT THE NEXT REGULAR MEETING FOLLOWING THAT AT WHICH SUCH VACANCY SHALL HAVE BEEN ANNOUNCED.

ARTICLES OF INCORPORATION (Attachment #1)

ARTICLE III
Purpose(s)

SECTION 1: The general purposes of this corporation shall be to organize into a non-profit association for the purpose of engaging in religious activities.

Specifically, the purposes of the Corporation are:

- A. To disseminate the word of God and the teachings of our Lord and Savior, Jesus Christ, and to minister to the needs of the community.
- B. To conduct for religious worship and instructing churches, schools, parsonages, and other institutions, connected therewith of a religious, educational, charitable and benevolent character to the end that its own members and others may be generally instructed and guided concerning those articles of faith which are most usually held amongst christians and to advance spiritual growth and enlightenment, moral and personal purity amongst its own membership and the people of the community in which it is located; to also educate, prepare and ordain christian men and women for the ministry of the Gospel of Jesus Christ.
- C. To provide for the fullest extent of christian fellowship for those of a born again experience, where Jesus Christ may be honored according to our distinctive testimony.
- D. To build, erect, construct and purchase any building including churches, synagogues, theatres, warehouses, shopping centers, etc. for the sole purpose of spreading the Gospel, and bringing good will to mankind.
- E. To carry on the business (not for profit) of christian drama and theatrical acting.
- F. To organize and establish youth groups for cultural enrichment, and to enhance their moral values in christian growth.
- G. To reach the disadvantaged and the less fortunate with the gospel, by feeding the hungry, sheltering the homeless, visiting the jail and prison and ministering in the street.

SECTION 2: To do any and all other things that are legal, under the laws of the State of Florida, or such other place or places, where it is qualified to operate.

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:
