ARTICLES OF INCORPORATION FOR

SADDLEWOOD ESTATES PROPERTY OWNERS ASSOCIATION, INC.

The undersigned cubscriber to these Articles of Incorporation, a natural person competent to contract, hereby associates to form a corporation not for profit under the laws of the state of Florida.

ARTICLE I - NAME

The name of this corporation shall be.

ARTICLE II - NATURE OF BUSINESS
