ARTICLES OF INCORPORATION

METRO MINISTRIES OF TALLAHASSEE INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

Article I - Name

The name of this corporation shall be Metro Ministries of Tallahassee Inc.

Article II - Address

The principle place of business of this corporation shall be 2450 Kimberly Lane, Tallahassee, Florida 32311. The mailing address will be Post Office Box 5616, Tallahassee, Florida 32314-5616.

Article III - Purpose

This corporation is formed for the purpose of establishing a local Inner City Sunday School Program, childrens church and church based anti-drug\anti-crime programs in Tallahassee, Florida. Metro Ministries of Tallahassee Inc. shall subscribe to the Statement of Fundamental Truths of the Assemblies of God (which shall be included in the bylaws) and the program philosophies of Metro Assembly of God. The corporation shall operate exclusively for such religious, charitable, and educational purposes as qualify as a nonprofit, tax-exempt organization under federal and state law. (which may include but not limited to sidewalk Sunday school programs, childrens church, local church, anti-drug\anti-crime programs, outreach programs, crisis and/or disaster aid programs, nursery schools, day-care centers, learning institutes)

ARTICLE IV - Directors

The directors of the corporation shall be the trustees. Directors and advisors may be appointed or elected or dismissed as regulated by the bylaws.

Article V - Powers


This corporation shall have all the powers, rights, and privileges of a corporation not for profit as described in section 617.0302 Florida Statutes.




