The undersigned, acting as incorporators of a corporation in accordance with the laws of the State of Florida, adopt the following Articles of Incorporation:

ARTICLE I

The name of the non-profit corporation shall be:

ARTICLE II

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III

The general objectives and purpose for which the non-profit corporation is organized is:

- 1) To bring into closer relation the home and the school, that parents and teachers may cooperate intelligently in the education of the children.
- 2) To do all acts and things necessary, convenient or expedient to carry on the above mentioned purposes.
- 3) To engage in all other activities not prohibited by the laws of Florida and to have all other powers given not-for-profit corporations under the laws of Florida.

ARTICLE IV

The qualification of membership:

The qualification of members and manner of admission to membership of the Corporation shall be as regulated by the Bylaws.

ARTICLE VIII

To the fullest extent permitted by Chapters 607 and 617 of the Florida Statutes (hereinafter referred to as the "statutes"), as the same may be from time to time amended, but subject to all restrictions set forth therein, the Corporation shall indemnify, hold harmless, and advance expenses to, as defined in the statutes, any person, his or her heirs, personal representative, executor, administrator or guardian who was or is a party to any proceeding, as defined in the statutes, by reason of the fact that he or she is or was a director or officer of the Corporation, against liability as defined in the statutes,

expenses as defined in the statutes and amounts paid in settlement incurred in connection with such proceeding, including any appeal thereof. This indemnification article shall specifically not apply to persons or entities who are or were employees or agents of the Corporation, but who are not or were not directors or officers of the Corporation.

ARTICLE IX

The income, distribution and dedication of assets is as follows:

The Corporation is a not-for-profit corporation. No part of the income of this Corporation shall be distributed to its members, except as compensation for services rendered, as provided in the Bylaws.

Upon the dissolution or winding up of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation shall be distributed equally among three of the closest not-for-profit organizations located in Manatee County, Florida, having the same or similar purposes.

ARTICLE X

Amendment of the Articles of Incorporation:

These Articles may be altered, amended or repealed in whole or in part by two-thirds vote of all the Directors, provided that any such changes shall be consistent with the laws of Florida which define, limit or regulate the powers of the Corporation or the Directors of the Corporation. An Amendment, upon its approval by the Secretary of State of Florida, filing in the office of the said Secretary of State, and payment of all required filing fees, shall be come and be taken as part of these Articles of Incorporation.
