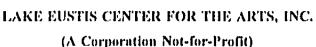

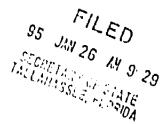

ARTICLES OF INCORPORATION OF





The undersigned, acting as incorporator of the Corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such Corporation:

ARTICLE 1 - NAME

The name of the Corporation is: LAKE EUSTIS CENTER FOR THE ARTS, INC.

ARTICLE II - DURATION

The period of duration of the Corporation is perpetual, unless sooner dissolved in accordance with the laws of the State of Florida, or by a court of competent jurisdiction.

ARTICLE III - PURPOSES AND POWERS

This corporation is a not for profit corporation, organized for the following purposes:

- (a) To promote, educate, and involve the community in all the arts;
- (b) To transact any or all lawful business, including, but not limited to, the purchasing and owning of real or personal property, receiving grants from governmental or charitable organizations, receiving gifts from individuals or businesses for use in the support of the corporation's purposes, and to do all other things incidental to or connected with the foregoing that are not forbidden by the Florida Corporation laws or by other laws or by these Articles of Incorporation, and to carry out the purposes in any state, territory, district, or possession of the United States or foreign country.
- (c) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing of

statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by: (1) a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law), or (2) a corporation, contributions to which are deductible under 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law).

(d) No member, director, trustee, officer, or private individual, shall be entitled to share in the distribution of any corporate assets upon dissolution of the Corporation. Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the Corporation, dispose of the residual assets of the Corporation as specified in these Articles of Incorporation.

ARTICLE IV - ADDRESS
