## ARTICLES OF AMENDMENT

OF ARTICLES OF INCORPORATION

1. ARTICLE III and ARTICLE IX of the Articles of Incorporation of FEED MY SHEEP EVANGELICAL PROGRAMS, INC., is amended to read as follows:

## ARTICLE III - PURPOSE

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meanings of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction, of the county in which the principal office of the orginaization is then located, exclusively for such purposes.

2.- There are no members entitled to vote. The foregoing amendment was adopted by the board of Directors of this Corporation on February 28, 1997.
