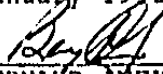

Article 1: The purposed for which the Unite World Children's Fund, Inc. is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(C)(3) of the Internal Revenue Code of 1986 with the corresponding provisions of any future United States Internal Revenue law.

Article 3: Notwithstanding any of the provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501(C)(3) of the Internal Revenue Code of 1986 of the corresponding provisions of any future United States Internal Revenue law.

Article 6: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(C)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government or to the state or local government for public purpose. Any such assets not so disposed of, shall be disposed of by the Court of Common Pleas of the county of which the principle place of Incorporation has been located, exclusively for such purposes or to such organizational organizations, as said court shall determine, which will be organized and operated exclusively for such purposes.
