ARTICLES OF INCORPORATION

ARTICLE 1

Name The name of this corporation is VILLAGE BOOSTER ASSOCIATION, INC (horeafter referred to as "Boosters"). Boosters shall be a nonprofit corporation,

ARTICLE II

Address The mailing address of Boosters chall be 5043 Paloma Drive, Tampa, Florida 33624.

ARTICLE III

Section 1. Purpose Boostors is a community-based organization formed to promote, protect and enhance the Carrollwood Village community through: (a) Support of the publication of the periodical known as Village Views (a joint publication of the homeowner associations known as Carrollwood Village Homeowners' Association, Inc., Carrollwood Village Phase Two Homeowners' Association, Inc. and Carrollwood Village Phase Three Homeowners' Association, Inc.) or a successor publication and, (b) Other means which Boosters may from time-to-time determine. Boosters seeks to ensure future publication of Village Views as a vehicle for publication of official Carrollwood Village homeowners' associations news, and as a means of promoting and supporting Associated Clubs (see below).

Soction 2. Momborship

- 2.a Boosters shall have five members and these members shall act as the Board of Directors of the organization. Each member shall be a property owner and reside in one of the three phases of the development known as Carrollwood Village and be a member in good standing of his or her respective homeowner association. Further: (a) One member shall be the Business Manager of Village Views as appointed by the Newsletter Committee of the joint Carrollwood Village Homeowners' Associations (Phase I/II/III), (b) One member shall be the Managing Editor of Village Views as appointed by the Newsletter Committee as described above, (c) One member shall be a member of the Village Views governing committee as appointed by his/her respective Broad of Directors (Carrollwood Village Homeowners' Associations, Phase I/II/III) and (d) Two members shall be elected by the membership of an Associated Club (see below).
- 2.b The officers of the Association shall be elected for one years terms in December of each year by majority vote of the Directors as described above in Section 2.a to fill the following positions: President, Vice-President, Secretary, Treasurer and Parliamentarian; said officers to assume office January 1; with the exception that officers elected in December 1994 shall service from time of election through December 31, 1995.

Section 3. Associated Clubs Boosters, by a 4/5 vote of the Board of Directors, may recognize certain groups or organizations to become "Associated Clubs". In addition to other criteria which the Board of Directors may from time-to-time adopt, such groups or organizations must: (a) Be composed exclusively of residents of the development known as Carrollwood Village and (b) Be shown to be making a contribution toward promoting Carrollwood Village as a family-oriented community, protecting and enhancing property values and in general seeking the common good of the community. Associated clubs shall jointly elect from their own members two members to serve on the Board of Directors of the Association.

ARTICLE IV

Management The general management of the affairs of Boosters shall be vested in the Board of Directors.

ARTICLE V

Powers The powers of the corporation are unlimited.

ARTICLE VI

<u>Begistered Agent</u> The Registered Agent of Boosters is JOHN R. MILEY, 5043 Paloma Drive, Tampa, Florida 33624.

ARTICLE VII

Incorporators The incorporators of this corporation are JOHN R. MILEY, 5043 Paloma Drive, Tampa, Florida 33624, TEAGUE CUDDEBACK, 13511 Clubside Drive, Tampa, Florida 33624 and JACK BUTLER, 13618 Greenfield Drive, Apartment 205, Tampa, Florida 33624.
