In reviewing our records, we note there is a(n) HISPANIC ASSOCIATION OF VOLUSIA, INC., Document number N50446, which was involuntarily or administratively dissolved.

Because of the similarities between the dissolved corporation and the one you are now seeking to file with us, and because it is our duty to assure that all fees due this office in accordance with section 607.0130(2)(c), Florida Statutes, are collected, we are returning the articles of incorporation unfilled and must request you reinstate the dissolved corporation by completing the enclosed reinstatement application and submitting it with the appropriate fees.

The fees to reinstate the corporation are as follows: \$175 reinstatement fee, \$61.25 filing fee per year for the years 1993 through the current year, \$138.75 supplemental fee for the years 1992 forward. 



### ARTICLE III - PURPOSES AND GOALS

The purposes and goals of this organization shall be exclusively charitable, educational and social with no intention to be involved in any profit-oriented activities which benefit its Board of Directors or members.

The organization will not be involved in any activities such as influencing political processes or legislation or any activities not permitted to be carried out on or by an organization exempt from Federal Income Tax Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Laws or any State laws controlling such tax exempt organizations.

Additionally, the organization will focus on the following activities relating to its purposes.

- To promote the Hispanic heritage by establishing and administering programs to encourage and enhance the Hispanic culture and values;
- To develop programs, to improve housing, education, employment opportunities, public safety, economic security, services and support for our senior citizens and the general health and welfare of Volusia County Community.
- To encourage the participation of all members of the Community in the activities of the Hispanic Association of Volusia County.
- To motivate the participation of all members of our youth community in the activities of this Association.

ARTICLE VIII

This organization can be dissolved or merged by various processes.

1. The action was considered at two regular consecutive meetings of the Board.
2. After being considered by the Board, the action shall be presented to the General Assembly, whether it be at the Annual or Special Meeting, and with the provision that the intent to take such action has been announced fifteen (15) days before the meeting.
3. Three-fourths (3/4) of the vote of those eligible votes at the assembly is required to effect a dissolution or merger of the organization.
4. Upon dissolution of the organization, assets shall be distributed to an exempt organization in Volusia County for use in their tax exempt purposes only. And furthermore, any assets not so distributed shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is located at the time of dissolution.

Approved this 13 day of July, 1995.

ARTICLE V

H. REMUNERATION

No member of the Board will accept remuneration of pay for services given to the Board or our organization. The Board shall set the salary and benefits of any employee that is so designated by the Board.
