ARTICLE I - NAME

The name of this corporation is Greek Orthodox Cultural Foundation of Florida, Inc. , a corporation not for profit

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

To promote the Greek Ortho Religion, Greek History & Culture , Philantropy, organize the construction & operation of a Greek Ortho Church or school and engage in fund raising.

ARTICLE IV - QUALIFICATION OF MEMBERS

Any person desiring to become a member must pay the dues of the organization and participate & contribute to organizati onal activities.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

Notwithstanding any provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law).

ARTICLE XI - DISSOLUTION

Upon the dissolution of the corporation, The Board of shall, after paying or making provision for the Directors all of the liabilities of the corporation, payment of dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, scientific purposes as shall at the time qualify as an exempt organization or organizations under 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States

Any of such assets not so disposed of shall be disposed of by the Circuit Court of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


