The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

Article I: Name

The name of the corporation shall be Mujer Cubana, Inc.
(Cuban Woman, Inc.)

Article II:

Article III: Purpose

The specific purpose for which this Non-Profit Corporation is organized are:

The purpose of this Non-Profit Corporation is to divulge the violation of human rights under Communist regimes via letters, radio programs, television, newspapers to the American people and people all over the world.

Article IV: Officers

The manner in which the officers are elected or appointed is as follows: The affairs of the Corporation will be managed by a President, a Vice President, a Secretary, and a Treasurer who will be elected for a period of two years in the year ending with an odd digit.
