ARTICLES OF INCORPORATION

PROJECT HELPING HAND, INC.

ES FEILED

We the undersigned, desire to form a not-for-profit corporation under the Florida Not For Provit Corporation Act of the State of Florida, pursuant to chapter 617 of the Florida Statutes, do hereby adopt and certify the following Articles of Incorporation for such a corporation.

Article I

The Name of the Corporation shall be **PROJECT IELPING HAND**, **INC.**, (the "Corporation") with the principal office of the corporation to be located in the city of Orlando, county of Orange, in the State of Florida. The Mailing Address is P. O. Box 2911, Orlando, Florida 32802-2911.

Article II

The period of duration of this Corporation is perpetual, unless dissolved according to Article IX of these Articles of incorporation or the Florida Not For Profit Corporation Act. Corporate existence shall commence upon the filing of these Articles of Incorporation by the Secretary of the State of Florida.

Article III

The purpose for which this Corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporations Act and the Florida Not For Profit Corporation Act that are organized for such purpose or purposes as follows:

The mission of Project Helping Hand, Inc. is to raise monies to facilitate the production and delivery of freshly cooked meals, free to those people with AIDS or HIV related illnesses and disabilities who need them. Individuals will be served without regard to race, age, color, sex, sexual orientation, religion, political affiliation, or national origin.

A primary function of the Corporation shall be to obtain public and private monies, and to provide equal access to nutritious meals to those affected by the AIDS virus.

The Primary means to be used by the corporation in achieving its purpose shall be:

1. To develop a methodology to obtain monies, i.e., fund raising, to meet the goals of the Corporation which in broad terms are two (2) nutritionally balanced meals, prepared, packaged, and delivered to the clients place of residence.

This Corporation shall be organized exclusively for charitable purposes and shall be authorized to exercise the powers permitted Not For Profit Corporations under Chapter 617, the Florida Not For Profit Corporation Act, of the Florida Statutes, provided, however, that this Corporation, in exercising any one or more such powers, shall do so in the furtherance of the exempt purpose for which it has been organized, as described in section 501 (c) 3 of the Internal Revenue Code.

Article IV

The method of election to the Corporations Board of Directors will be outlined in the Corporations By-Laws.

Article V

The name and street address of the Corporation's initial registered agent and his or her office is as follows:

Dale J. Johnson, 1893 Cranberry isles Way, Apopka, Florida 32712-2150

Article VI

The Number of directors/incorporators constituting the initial Board of Directors of the Corporation is three (3). The Board shall be composed of no less than three (3) members, the exact number to be determined annually by the Board of Directors. The Directors shall be elected, or appointed, in accordance with the By-Laws of the corporation. The names and addresses of the persons who are the initial directors/incorporators of the Corporation are as follows:

Stephen DeMatteis of 2506 South Conway Road #15, Orlando, Florida 32812

M. Patrick O'Brien of 1664 Baker Street N.E., Palm Bay, Florida 32907

Article VII

The Board of Directors is empowered to make, alter, or repeal the Articles of Incorporation of this Corporation without restriction of their powers conferred by statute.

Article VIII

No part of the net earnings of the Corporation shall insure to the benefit of, or be distributable to its members, directors, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the

publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) 3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) 2 of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article IX

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of sections 501(c)3 and 170(c)2 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.
