ARTICIES OF INCORPORATION OF THE ATTRIBUTER LETTE, INC.

ARTICLE I. NAME

The name of the Corporation is Theateriffic, Incorporated.

ARTICLE II. DURATION

The duration of the Corporation is perpetual. Voluntary dissolution of the corporation may occur through adoption of a dissolution resolution by the Board of Directors followed by filing of Articles of Dissolution with the Secretary of State. The remaining corporate assets shall be distributed to another non-profit organization with a related mission.

ARTICLE III. PURPOSES

- A. Theateriffic, Inc. is a not-for-profit corporation organized under Chapter 617, Florida Statues for exclusively charitable purposes dedicated to promoting the welfare of children. Specific purposes are:
- 1. To teach ethics and values to pre-kindergarden through 12th graders, encompassing cultural diversity, justice, friendship, love, loyalty, honesty, respect, responsibility and caring for others and their environment.
- 2. To provide the oportunity for all children and in particular, economically depressed, minority and physically challenged children to experience the magic of theater and its powerful messages through live, creative productions.
- 3. To teach about current issues impacting modern-day society, including AIDS, teenage parenting, alcohol, drugs and child abuse.
- 4. To demonstrate skills and techniques for non-violent interpersonal relationships.
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- C. The Corporation shall not, however, engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code. No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors or officers, but the Corporation shall e authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

ARTICLE IV. MEMBERS

AMENDMENTS TO THE ARTICLES OF INCORPORATION OF THEATERIFIE, INC. as of April 17, 1995.

ARPICIAL II. DURATION

Delete last sentence: "The remaining corporate assets shall be distributed to another non-profit organization with a related mission."

Substitute: Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501[c][3] of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the county in which the principal office of the organization is then located, exclusively for such purposes.

ARTICLE III. PURPOSES

Addition: The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501[c][3] of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Pevenue law.

Not withstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501[c][3] of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
