### ARTICLES OF INCORPORATION

OF

THE CYPRESS COVE HOMEOWNER'S ASSOCIATION, INC.

# Article 1. NAME

The name of this Association shall be THE CYPRESS COVE HOMEOWNER'S ASSOCIATION, INC. (hereinafter the "Association").

## Article 2. PRINCIPAL OFFICE OF THE ASSOCIATION

The principal office of the Association is located at 125 N. Ridgewood Avenue, Daytona Beach, Florida 32114

### Article 3. REGISTERED OFFICE AND REGISTERED AGENT

Laurence H. Bartlett, Attorney at Law, whose address is 125 N. Ridgewood Avenue, Daytona Beach, Florida 32114 is hereby appointed the initial Registered Agent of the Association.

#### Article 4. PURPOSE

This Association is formed for the purpose of uniting the interests of the homeowner's of CYPRESS COVE subdivision and to meet the common objectives of the homeowners. It is formed, NOT FOR PROFIT, in compliance with the requirements of Chapter 617 Florida Statutes.

## Article 5. OBJECTIVES

The objectives of this Association shall be to:

- (a) Protect and promote the interests of the residents of the CYPRESS COVE subdivision.
- (b) Improve and maintain good communication and understanding among the homeowners, between the homeowners and the City of Port Orange, and between the homeowners and neighboring subdivisions.
- (c) Identify and resolve problems common to homeowners of CYPRESS COVE.
- (d) Provide a medium for homeowners to work together to maintain a high standard of appearance and conduct for the subdivision so as to maintain the value of each individual economic investment, and contribute to a desirable residential neighborhood life style.
- (e) Provide a medium to identify and attain the common goals of the homeowners.

# Article 6. MEMBERSHIP

Each homeowner within the CYPRESS COVE subdivision shall be entitled to membership in the Association.

Each member shall be entitled to one vote for each lot owned. When more than one person owns an interest in any lot, all such persons shall be members. The vote for such lot shall be exercised as the owners/members determine, but in no event shall more than one vote be cast with respect to any lot.

# Article 7. OFFICERS AND COMMITTEES

The regular officers of the Association shall consist of the President, Vice-President, Secretary, Treasurer and Board of Directors (6), all elected at an annual meeting to serve for a period of one year, except that the immediate past President shall automatically be a member of the Board of Directors and shall serve as Chairperson of the 6 member Board.

Standing Committees will be:

Block Representative/Membership Committee
Communication Committee
Hospitality Committee
Historical Committee
Civic Affairs Committee
Community Youth Committee
Lakes Control Committee
Coalition Committee

Other committees may be established by the President with the approval of the Board of Directors.

### Article 8. AMENDMENTS

The Constitution and By-Laws may be amended by a simple majority vote of the members attending a scheduled meeting, with a quorum required of 25% of the voting membership providing that the proposed amendment has been made available to the membership at least fifteen (15) days prior to the meeting.

## Article 9. DISSOLUTION

The Association may be dissolved with the assent given in writing and signed by not less than two-thirds (2/3) of the members. Upon dissolution of the Association, other than incident to a merger or consolidation, the assets of the Association shall be distributed as the Board of Directors shall decide. This procedure shall be subject to court approval upon dissolution pursuant to Chapter 617, Florida Statutes.

### Article 10. DURATION

Existence of the Association shall commence with the filing of these Articles of Incorporation with the Secretary of State, Tallahassee, Florida. The Association shall exist in perpetuity.

### Article 11. BYLAWS

The Bylaws of this corporation shall be adopted by the directors at their first meeting. The Bylaws may be amended at a regular or special meeting of the members by a vote of a majority of a quorum of members present in person or by proxy. In the case of any conflict between the Articles of Incorporation and the Bylaws, the Articles shall control.
