## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

THE 55th STRAT RECON WING ASSOCIATION, INC. LAHASSEE, A Florida Corporation Not for Profit

PURSUANT TO the provisions of Section 617.1006, Florida Statues, the undersigned corporation adopts the following Articles to its Articles of Incorporation:

FIRST: Amendments adopted:

## ARTICLE III

patriotism, love of country and pleasure of association for recreational purposes of former members and associates of the United States Air Force Unit known as the 55th Strategic Reconnaissance Wing. This Corporation shall not engage in any profitable activity and there shall be no net earning which inure to the benefit of any member, officer or director. This Corporation is organized pursuant to Chapter 617, Florida Statute (1993).

## ARTICLE VIII
