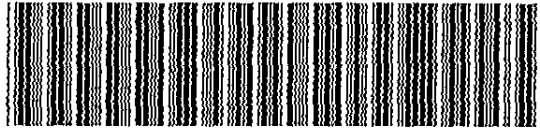

ARTICLES OF INCORPORATION  
OF

PURSUANT TO the provisions of Section 617.1002, Florida Statutes, the undersigned, in behalf of the above named Corporation, restates and adopts the following Amended Article III as follows:

First: Revised Amendment adopted:

ARTICLE III
