### ARTICLE III Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

C. The order of nominations shall be: President, Vice-President, Financial Secretary, Recording Secretary, Chief Steward, Trustees, Seargent at arms, and Delegates to District Council--- 1 (and G.E. Conference Board, if applicable).
