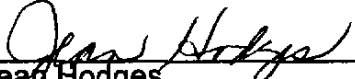
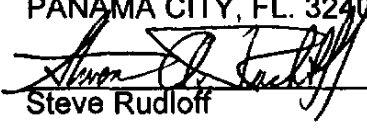

NO EARNINGS OF THE CORPORATION WILL IN ANY EVENT INURE TO THE PERSONAL BENEFIT OF ANY MEMBER, OFFICER, OR BOARD MEMBER PROVIDED THAT REASONABLE COMPENSATION MAY BE PAID TO ANY MEMBER, OFFICER OR BOARD MEMBER OF THE CORPORATION IN EXCHANGE FOR SERVICES ACTUALLY RENDERED TO OR FOR THE BENEFIT OF THE CORPORATION IN FURTHERANCE OF ONE OR MORE OF ITS PURPOSES STATED HEREIN.
3. THE CORPORATION SHALL HAVE NO CAPITAL STOCK, PAY NO DIVIDENDS, DISTRIBUTE NO PART OF THE INCOME TO ITS MEMBERS, DIRECTORS, OR OFFICERS AND PRIVATE PROPERTY OF THE SUBSCRIBERS, MEMBERS, DIRECTORS AND OFFICERS SHALL NOT BE LIABLE FOR THE DEBTS OF THE CORPORATION.
