WE, THE UNDERSIGNED, ACTING AS INCORPORATORS OF A CORPORATION PURSUANT TO CHAPTER 617, FLORIDA STATUTES, ADOPT THE FOLLOWING ARTICLES OF INCORPORATION

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE KIWANIS CLUB OF SAINT ANDREW, PANAMA CITY, FLORIDA, INC.

ARTICLE II

THE MAILING ADDRESS AND PRINCIPAL OFFICE OF THIS CORPORATION SHALL BE 2336 INDUSTRIAL DRIVE, PANAMA CITY, FLORIDA, 32405.

ARTICLE III PURPOSES

THE PURPOSES OF THE CORPORATION ARE:

- 1. TO GIVE PRIMACY TO THE HUMAN AND SPIRITUAL RATHER THAN TO THE MATERIAL VALUES OF LIFE.
- 2. TO ENCOURAGE THE DAILY LIVING OF THE GOLDEN RULE IN ALL HUMAN RELATIONSHIPS.

NO EARNINGS OF THE CORPORATION WILL IN ANY EVENT INURE TO THE PERSONAL BENEFIT OF ANY MEMBER, OFFICER, OR BOARD MEMBER PROVIDED THAT REASONABLE COMPENSATION MAY BE PAID TO ANY MEMBER, OFFICER OR BOARD MEMBER OF THE CORPORATION IN EXCHANGE FOR SERVICES ACTUALLY RENDERED TO OR FOR THE BENEFIT OF THE CORPORATION IN FURTHERANCE OF ONE OR MORE OF ITS PURPOSES STATED HEREIN.
- 3. THE CORPORATION SHALL HAVE NO CAPITAL STOCK, PAY NO DIVIDENDS, DISTRIBUTE NO PART OF THE INCOME TO ITS MEMBERS, DIRECTORS, OR OFFICERS AND PRIVATE PROPERTY OF THE SUBSCRIBERS, MEMBERS, DIRECTORS AND OFFICERS SHALL NOT BE LIABLE FOR THE DEBTS OF THE CORPORATION.

- 4. NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE CORPORATION SHALL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY: (A) AN ORGANIZATION EXEMPT FOR FEDERAL INCOME TAXATION UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1954(OR CORRESPONDING PROVISIONS OF ANY SUBSEQUENT REVENUE LAWS) OR(B) A CORPORATION CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170(C)(2) OF THE INTERNAL REVENUE CODE OF 1954 (OR CORRESPONDING PROVISIONS OF THE SUBSEQUENT REVENUE LAWS)
- 5. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE THE CARRYING ON OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, AND THE CORPORATION SHALL NOT PARTICIPATE IN OR INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF THE STATEMENTS), ANY POLITICAL CAMPAIGN ON BEHALF OF OR IN OPPOSITION TO ANY CANDIDATE FOR PUBLIC OFFICE.

ARTICLE IX DISSOLUTION OF ASSETS

IN THE EVENT OF DISSOLUTION, ALL ASSETS REMAINING AFTER PAYMENT OF ALL COSTS, AND EXPENSES OF SUCH DISSOLUTION SHALL BE DISPERSED TO SUCH SCIENTIFIC, EDUCATIONAL AND CHARITABLE ORGANIZATIONS RULED EXEMPT BY THE INTERNAL REVENUE SERVICE UNDER SECTION 501(C)(3) SECTION 170 (C)(3) OF THE INTERNAL REVENUE CODE OF 1954 (OR SUBSEQUENT REVENUE LAWS) HAVING GOALS AND OBJECTIVES SIMILAR TO THOSE OF THIS CORPORATION AS MAY BE SELECTED BY THE LAST BOARD OF DIRECTORS, AND NONE OF THE ASSETS WILL BE DISTRIBUTED TO ANY MEMBERS, OFFICERS OR DIRECTORS OF THIS CORPORATION.
