

#### ARTICLE IX

The objective of the corporation will be a not for profit social and cultural association dedicated to keeping people from the municipality of Rodas (a town in Cuba ) together by having meetings and events of social and cultural interest. all these events will be funded by donations and membership dues.

#### ARTICLE X

The corporation shall have the further right and power to, from time to time, determine whether and to what extent, at what time and places and under what conditions and regulations the accounting books of this Corporation, shall be open to the inspection of the directors, and no members shall have any right of inspections any account book or document of this Corporation, except as conferred by statute, unless authorized by resolution of the stockholders or Board of Directors. The Corporation, in its By-laws confers power upon its Board of Directors or Officers, in addition to the foregoing and in addition to the powers authorized and expressly conferred by Statute. Both members and Directors shall have the power, if the By-laws so provide, to hold their respective meeting and to have one or more offices, within or without the State of Florida, and to keep the books of this Corporation subject to the provisions of the statute outside the State of Florida at such places as may from time to time be designated by the Board of Directors.

This Non Profit Corporation reserves the right to amend, alter, change or repeal any provisions contained in this Certificate of Incorporation in the manner now hereafter prescribed by statute, and all rights conferred upon the members herein or granted subject to this reservation.

#### ARTICLE XI

This non profit corporation and its directors have the right to act in the best interest of its members and will operate according to the rules and regulations stipulated by the State of Florida Laws which apply to not for profit organizations.

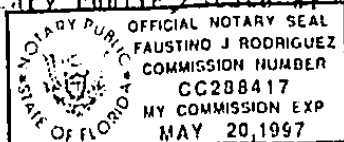


