**PLAN OF DISTRIBUTION OF ASSETS  
FOR  
MEDICAL EDUCATION FUND, INC.  
(a Florida Not For Profit Corporation)**

*Pursuant to Section 617.1406 of the Florida Not For Profit Corporation Act, this Florida not for profit corporation has adopted the following Plan of Distribution of Assets:*

1. This plan is effective as of September 11, 2015.
2. Medical Education Fund, Inc. (the "Corporation") shall pay and discharge all liabilities and obligations of the Corporation or shall make adequate provisions to pay and discharge all liabilities and obligations of the Corporation.
3. Any assets held by the Corporation upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution of the Corporation, shall be returned, transferred, or conveyed in accordance with such requirements.
4. The assets received and held by the Corporation subject to limitation permitting their use only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution, shall be transferred or conveyed to one or more organizations, which are exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1986, as amended.
5. All other remaining assets of the Corporation (if any) shall be distributed in accordance with the Bylaws of the Corporation to one or more organizations which are engaged in activities substantially similar to those of the Corporation and which qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

The undersigned officer of the Corporation hereby certifies that the Corporation has no members entitled to vote on the dissolution and that on September 11, 2015, the Board of Directors of the Corporation unanimously adopted this Plan of Distribution of Assets.
