A FLORIDA CORPORATION NOT FOR PROFIT

ARTICLE 1. NAME

The name of this corporation is MYSTIC ORDER OF BISCUITS OF ESCAMBIA COUNTY FLORIDA, INC.

ARTICLE 2. ENABLING LAW

This corporation is organized pursuant to the Corporations Not for Profit law of the State of Florida, set forth in Part One of Chapter 617 of the Florida Statutes.

ARTICLE 3. PURPOSES
