ARTICLES OF INCORPORATION OF
MYSTIC ORDER OF BISCUITS OF ESCAMBIA COUNTY FLORIDA, INC.

A FLORIDA CORPORATION NOT FOR PROFIT

ARTICLE 1. NAME

The name of this corporation is MYSTIC ORDER OF BISCUITS OF ESCAMBIA COUNTY FLORIDA, INC.

ARTICLE 2. ENABLING LAW

This corporation is organized pursuant to the Corporations Not for Profit law of the State of Florida, set forth in Part One of Chapter 617 of the Florida Statutes.

ARTICLE 3. PURPOSES

(a) The specific and primary purpose for which this corporation is organized is to provide for the enjoyment, recreation, protection or other use or benefit of the members; including but not limited to sponsorship of year round Mardi Gras social events and promote fellowship, goodwill and entertainment of its members.

(b) This corporation is organized and operated exclusively for pleasure, recreation, and other nonprofit purposes, and no part of any net earnings shall inure to the benefit of any member, director, or officer.

(c) This corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida, provided, however, that this corporation is not empowered to engage in any activity that in itself is not in furtherance of its purposes as set forth in subparagraphs (a) through (b) of this article.

ARTICLE 4. TERM

This corporation shall have a perpetual existence.

ARTICLE 6. MEMBERSHIP

The authorized number, qualifications, and manner of admission of members of this corporation, the different classes of membership, if any, the property, voting and other rights and privileges of members, the liability of members for dues or assessments and the method of collection thereof, and the termination and transfer of membership shall be set forth in the by-laws of this corporation.

ARTICLE 7. MANAGEMENT OF CORPORATE AFFAIRS

(a) Board of Directors: The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of not less than three (3) directors. The number of directors herein provided for may be changed by a by-law duly adopted by the members entitled to vote. Directors shall be elected annually by a majority vote of the membership.

ARTICLE 11. DISSOLUTION

This corporation shall be dissolved and its affairs wound up by a majority vote of the membership.

In the event of dissolution, property of the corporation shall be distributed to the Escambia County Search and Rescue.

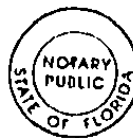

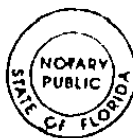
