The undersigned, for the purpose of forming a corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is IGLESIA CRISTIANA "LA GRAN COMISION", INC.

English translation: CHRISTIAN CHURCH "THE GREAT COMMISSION", INC.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be 709 S.W. 1st Ave., Hallandale, FL 33009.

ARTICLE III: PURPOSE

The purpose of the corporation is to be a religious worship organization.

ARTICLE IV: QUALIFICATION

The qualifications for members and the manner of their admission are stated in the bylaws of the Corporation.

ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT

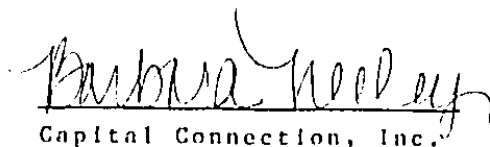
ARTICLE X: AMENDMENTS
